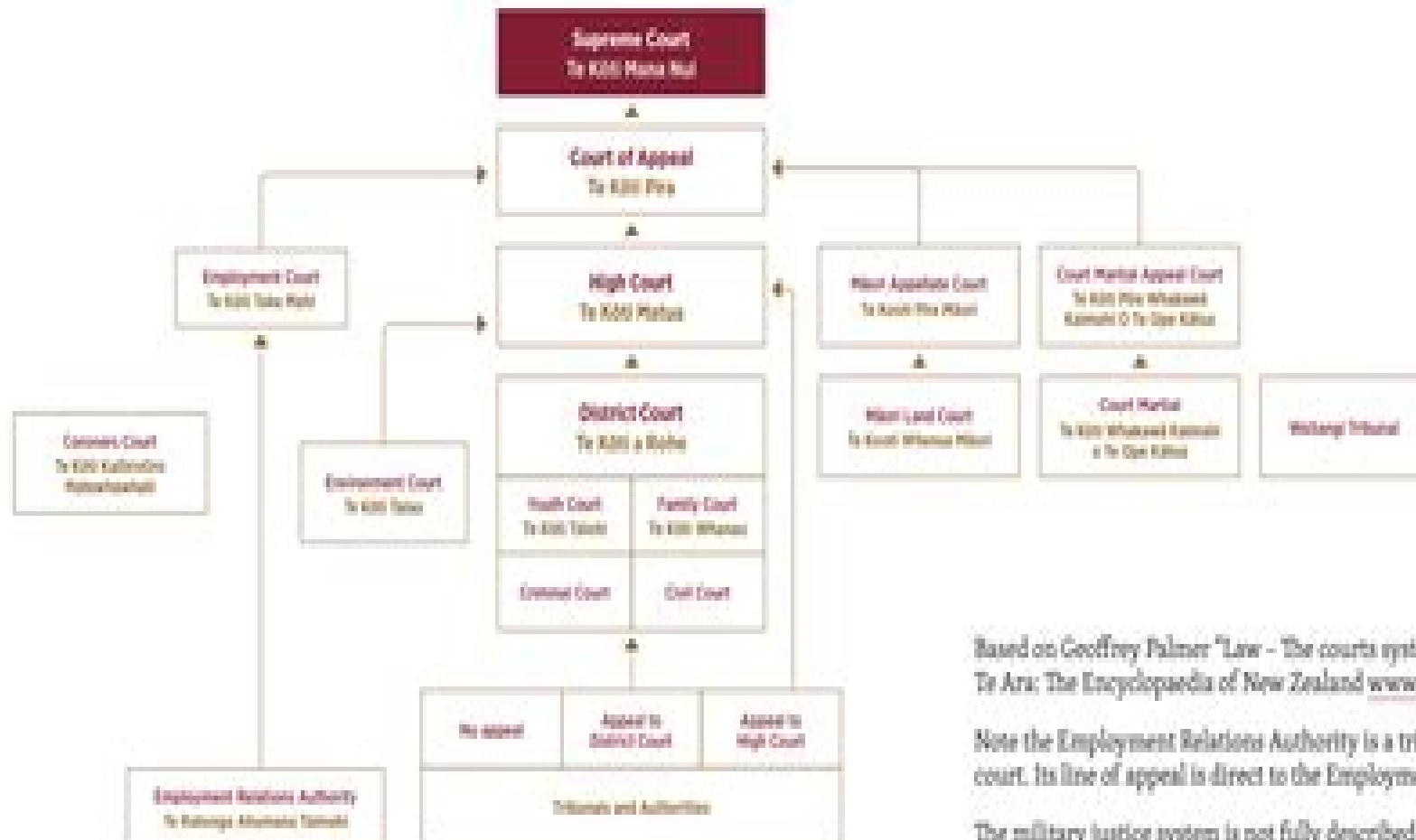


New Zealand's court system

In New Zealand, there are a range of trial, appellate, and specialist courts. The hierarchy of these courts is illustrated in the diagram below.
