#### ABSTRACT

In today's rapidly evolving, technologically-focused economy, a higher education degree is a near-requirement in order to enter a professional field and earn a livable wage. As currently written, however, the Internal Revenue Code (the Code) disallows cost recovery for higher education expenditures in nearly all situations. The failure of the Code to allow cost recovery of higher education expenditures, while broadly providing for cost recovery of other expenditures, has ramifications for the equitable tax treatment of education costs and the long-term prospects of our economy. This Article advocates an amendment to the Code to allow cost recovery of higher education expenditures through amortization.

#### I. INTRODUCTION

As currently written, the Code disallows deductions for education expenditures in all but a few limited circumstances.\(^1\) And the Code does not allow taxpayers to amortize these costs in any situation.\(^2\) Specifically, cost recovery is disallowed for expenditures for education that enable the taxpayer to meet the minimum educational requirements of a trade or business or qualify for a new trade or business.\(^3\) The Code does, however, allow cost recovery of expenditures for education necessary to satisfy formal conditions for employment retention or for the maintenance or improvement of vital skills.\(^4\) The distinction between nondeductible and deductible education expenses hinges on the Code's classification of the former as \(^6\)personal expenditures or \(^6\). \(^6\) an inseparable aggregate of personal and capital
