to stand in the way of 25 States reinforcing the eurozone but sees the use of the institutions outside the EU Treaties without  
the consent of all 27 Member States as unlawful irrespective of the consequences to and the lack of concessions for the  
United Kingdom and the current failure to take the issue of legality further To the Committee it therefore seems that the SCG  
Treaty must be deemed unlawful in the Government s view Although questions have been raised as to what the UK achieved  
by the use of its veto the Committee concludes that the veto was justified because of the very real concerns about a breach of  
EU law even if this was not the reason given exclusively for the use of the veto in the first place The Committee notes that
