highly dependent on the ecosystem they are operating in We can learn from international experiences that Europe needs to develop innovative regulatory models and be ready to test new institutional schemes that involve consumers to support the energy transition The work ahead goes beyond monitoring what the Clean Energy Package can deliver we have to anticipate new trends and take action to give more clarity to what DSOs and TSOs can do together and avoid new bottlenecks concludes Chlo Le Coq
