Work rules:

You must follow these work rules to get SNAP benefits.

- 1. Apply to all future foodbanks or work programs.
- 2. Inform the job or work program you are in.
- 3. Accept jobs if you are offered one.
- 4. Continue go to any program without interruption. If you cannot if you have a good reason, call the Texas Health and Human Services Commission (THHS) for advice. Call toll free 1-877-673-6737. If you call you must leave a message, press 3.

If you don't follow the work rules:

The penalties are:

- 1. First time, no SNAP benefits for one month and interruption of future SNAP benefits.
- 2. Second time, reduced SNAP benefits for three months and further penalized future the rules.
- 3. Third time, no SNAP benefits for six months and further penalized future the rules.

Penalties apply when the work rules are followed again.

Your rights and responsibilities:

- 1. You do not have to leave (quit) if you receive the minimum wage, or if the work program satisfies a need why you cannot quit for you.
- 2. You can appeal a determination about your case.
- 3. If you move, telephone or work program, call THHS your new address.
- 4. THHS will show amount of money you get from a job or work program, changes.
- 5. THHS will show you how you can get a job or work program.
- 6. Call THHS for more information about rules.

NOTE: THHS found that a person is given the work rules and follow the SNAP work rules. By signing this form, the person agrees to follow the SNAP work rules.
