A great deal of psychological research on jurors and other decision makers shows that our brains intuitively leap to story telling before we rationally analyze facts or evidence. Weaving details into a narrative is how we make sense of the world and it's very hard to suppress this tendency. Consequently a majority of jurors actually make up their minds before they have heard much of the evidence. Judges, arbitrators and mediators have similar biases. The Jury Crisis deals with an important social problem, namely the near collapse of a thousand year old institution and proposes how to fix the jury system and restore trial by jury to a more prominent place in American society.
