# **Enrollment Status**

- Enrollment status must be calculated for each term for an undergraduate program based on—
  - Academic year in weeks and hours, and
  - Weeks of instructional time in the term.
- In calculating full-time and other enrollment statuses, all fractions are rounded up (even if less than ½) if the program only has whole credit hours. If the program has courses in fractions of credits, may round up or use actual fraction from the enrollment status calculation.
