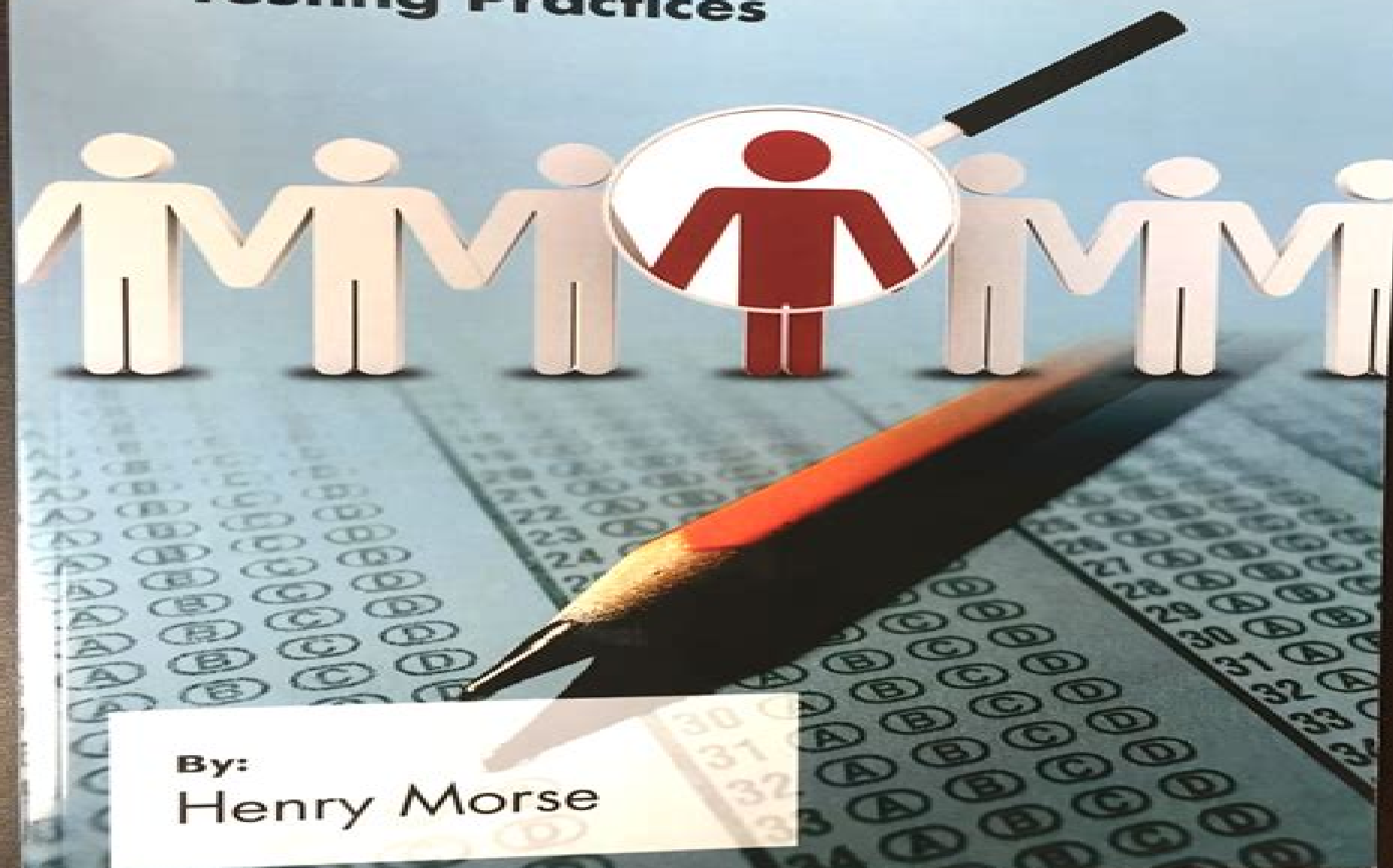

state contracts or other funding to discuss union matters with employees As long as employers avoid coercion federal law seeks to promote wide open debate on labor issues Chamber of Commerce v Brown 128 S Ct 2408 2008 Another Supreme Court ruling discussed allows unions to charge non members who pay agency fees in lieu of joining the union amounts representing certain expenses of national litigation Locke How Honesty Testing Works Michael H.
