#### Model Rules: Origins and Evolutions, Plus Other Topics

- 1908—Canons of Ethics—terse, simple, and vague/incomplete
- 1969—Model Code—DRs=disciplinary rules; ECs=aspirational nonbinding commentary
- 1977—ABA sets out to revise
  - 1983—Model Rules are born.
  - Rules: disciplinary rule, can be enforced
  - Comments: nonbinding, but informative
- 2000—E2K
- 2013—intermediate tweaking of rules, "Ethics 2020"
- Now: ABA is looking at changes to advertising

#### Current Model Rules

- Most states keep current with ABA amdts to Model Rules, but a few state's rules are worded exactly same as ABA, and authorities in a state may interpret the same rule differently than the ABA or another state
- Some states adopted the MRs but with significant changes (GA)
- Two main components to rules: Rules and Comments.
  - Rule 1.0—definitions. Preamble ¶ 14 and 15—shall and may difference
  - Ex: if rule says L who knows confidential info may reveal it to save life, L does not have to revel it
- Most rules: (1) prohibition; (2) exception. Eg the general rule is that an L who knows C's
  confidential info can't reveal it, with some permitted and a few required exceptions (may
  or shall). If it is not permitted or req'd and the L reveals confidential info, L is subject to
  discipline
- Comments and Preamble ¶ 21
  - "Should" and Preamble ¶ 14—aspirational
  - Importance of comments in MPRE: if rule says "must" but comment says "should," the comments turn "should" into "must"—emts are more important

#### How to Read Rules/Comments

- First: Text of Rule. Preamble ¶ 14,15,18
- Then: Comments: comment structure (see cmts to MR 1.6 and 1.7)
- And: state and local bar assocs issue opinions on state rules, ABA committee issues opinions on MRs, Restatement and Law Governing Lawyers. Court and bar decisions contain grievances, disqualifications (DOs), exclusions of evidence, sanctions

#### Structure of MRs

 1. C-L relationship, 2. Counselor, 3. Advocate, 4. Transactions with non-Cs, 5. Law firms and assocs; 6. Public service; 7. Info about legal services (ads); 8. Maintaining profession's integrity

#### Rules Applied or Interpreted in Different Context

- Rules are for discipline arising from grievance, which is: discipline does NOT require damage to C, but malpractice DOES
- Preamble ¶ 20: violation of rule does not itself give rise to claim nor create presumption that legal duty was breached, but b/c rules establish a "standard of care," a violation can show a breach of duty, in for ex. a malpractice case against L.
