The Treaties of Maastricht, Amsterdam, and Nice all expanded competencies further so that by the time the heads of government met in Lisbon in 2007 to sign the EU's latest treaty, the extent of supranational control over important aspects of social policy making was quite impressive. It examines the reasons for the increased role of the EU in the area in spite of formidable obstacles and details its effects in member states where social provision is often the biggest item in government budgets and a crucial issue in national elections.
