The Fus Fixico Letters Alexander Lawrence Posey,1993-01-01 Alexander Posey 1873 1908 was the most accomplished Indian writer of his day and one of the most important in American history A well known lyric poet journalist and political humorist in the Creek Nation his literary works excited admiration and envy beyond the Indian Territory and throughout the country His most significant contribution to literature is the body of humorous articles now called The Fus Fixico Letters In 1902 in the Indian Journal his newspaper Posey introduced his most beloved persona Fus Fixico or in English Heartless Bird an alleged conservative Snake Creek Until Posey s death in 1908 Fixico retailed his conversations with his friends Hotgun and Toofpafka Micco conveying their points of view about Indian politics the prospects for an Indian state joining the Union the irresponsibility of distant newspapers that reported on Indian events without stepping a foot from the road and many other topics This collection is especially timely since very little is known or appreciated about American Indian literature prior to the 1960s A labor of years it has taken uncommon diligence to find and annotate the letters some of which now exist in a single fragile copy of the Indian Journal There are 72 letters in all

Chinnubbie and the Owl Alexander Lawrence Posey,2005-12-01 Though he died at the age of thirty four the Muscogee Creek poet journalist and humorist Alexander Posey 1873 1908 was one of the most prolific and influential American Indian writers of his time This volume of nine stories five orations and nine works of oral tradition is the first to collect these entertaining and important works of Muscogee literature Many of Posey s stories reflect trickster themes his orations demonstrate both his rhetorical prowess and his political stance as a Progressive Muscogee and his works of oral tradition reveal his deep cultural roots Most of these pieces which first appeared between 1892 and 1907 in Indian Territory newspapers and magazines have since become rarities many of the original pieces surviving only as single clippings in a few archives

Fixico, 2024-10-22 Few people today know that the forty sixth state could have been Sequoyah not Oklahoma The Five Tribes of Indian Territory gathered in 1905 to form their own Indian led state Leaders of the Cherokees Chickasaws Choctaws Muscogees and Seminoles drafted a constitution which eligible voters then ratified In the end Congress denied their request but the movement that fueled their efforts transcends that single defeat Researched and interpreted by distinguished Native historian Donald L Fixico this book tells the remarkable story of how the state of Sequoyah movement unfolded and the extent to which it remains alive today Fixico tells how the Five Nations after removal to the west negotiated treaties with the U S government and lobbied Congress to allow them to retain communal control of their lands as sovereign nations In the wake of the Civil War while a dozen bills in Congress proposed changing the status of Indian Territory the Five Tribes sought strength in unity The Boomer movement and seven land dispensations beginning with the famous run of 1889 nevertheless eroded their borders and threatened their cultural and political autonomy President Theodore Roosevelt ultimately declared his support for the merging of Indian Territory with Oklahoma Territory paving the way for Oklahoma statehood in 1907 and shattering the state of Sequoyah dream Yet the Five Tribes persevered Fixico concludes his narrative by highlighting recent U S Supreme Court decisions most notably *McGirt v Oklahoma* 2020 that have reaffirmed the sovereignty of Indian nations over their lands and people a principal inherent in the Sequoyah movement Did the story end in 1907 Could the Five Tribes revive their plan for separate statehood Fixico leaves the reader to ponder this intriguing possibility *The Red Land to the South* James Howard Cox, 2012 The forty years of American Indian literature taken up by James H Cox the decades between 1920 and 1960 have been called politically and intellectually moribund On the contrary Cox identifies a group of American Indian writers who share an interest in the revolutionary potential of the indigenous peoples of Mexico and whose work demonstrates a surprisingly assertive literary politics in the era By contextualizing this group of American Indian authors in the work of their contemporaries Cox reveals how the literary history of this period is far more rich and nuanced than is generally acknowledged The writers he focuses on Todd Downing Choctaw Lynn Riggs Cherokee and D Arcy McNickle Confederated Salish and Kootenai are shown to be on par with writers of the preceding Progressive and the succeeding Red Power and Native American literary renaissance eras Arguing that American Indian literary history of this period actually
