next twenty five years As a result direct care workers such as home care aides and certified nursing assistants CNAs will become essential to many more families Yet these workers tend to be low paid poorly trained and receive little respect Is such a workforce capable of addressing the needs of our aging population In Who Will Care for Us economist Paul Osterman assesses the challenges facing the long term care industry.
