Custom – common definition: it is accepted practice or that it is a practice of longstanding No clear list of norms, complex to determine

Clear arguments can be made both for and against 2003 Invasion of Iraq

CIL describes what IL there are and evaluating the legality of state action

Historical acceptance

CIL attempts to create normative structures and rules to constrain and evaluate the conducted of states → but these structures & rules are themselves drawn from state conduct. [chicken v egg]

Objections to IL - empty legal talk; reflection of desires of strong states

Treaties bind states who sign/ratify – while norms of CIL are binding from moment they come into being

Pacta sund servanda - bindingness of treaties

Tacit consent – failure to actively protest a norm during its evolution is deemed to be an endorsement of it

What counts as CIL // legal norm?

- Constant need to differentiate legal norms from moral and political ones (ontological dispute)
- Moral analyses vs political process
- Content of norms vs process within which norms are created
- CIL is a system of rules derived from the observable practice of states
- Contains a subjective element

2 constituent elements of CIL: state practice and opinio iuris (or juris)

No state alone controls the law making and law changing process under CIL.

It is an aggregation of state practice with intent that creates CIL

Approach to state behavior

opinio iuris (or juris) is belief of law four generic forms of state conduct:

- Conduct in compliance with existing law'
- 2) Conduct at variance with existing law, but not intended to create law:
- 3) Conduct in breach of old law, but not intended to create new law; and
- 4) Conduct in breach of old law, but intended to make new law:
 - a. Which falls; or
 - b. Which succeeds.

State practice – what states actually do. That portion of state conduct which manifests & indicates opinio juris; conduct intended by states to create new law, or reform existing law.

Opinio iuris sive necessitates – belief of law or necessity; the subjective element

opinio iuris is a community concept. Must be held by state, but also by its peers.

Norms can evolve only from consistent conduct and belief of states (state practice) a manifestation of the will of states draw directly and exclusively from the observed

CIL is a manifestation of the will of states draw directly and exclusively from the observed practice of the international community of states viewed as a whole.

CIL provides conceptual lens to evaluate state behavior as well as motivations for action, support, and dissent.
