hardships encountered by the 12 000 prisoners Later when we walked out the Nurnberg the numbers swelled to over 100 000 I received considerable encouragement from the Secretary of the 467th Bomb Group Organization to enlarge the scope of the account to include a biographical account of my life leading up to my experiences as a POW and of my life following WW II I didn t become a member of the 467th Bomb Group Organization until they held a reunion in San Antonio Texas Since that time I have not missed any of the reunions At these events I have met many children who had a parent who served in the 467th Bomb Group They have expressed keen interest in reading this account since it may also parallel the experiences of one of their parents
