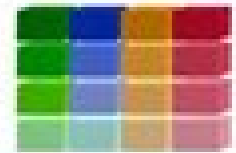


Eligibility



Nationality

- open on equal terms to all natural and legal persons of the EU Member States & the countries covered by the Regulation under which the contract is financed
- applies to both companies and individual experts

Origin

- all supplies and equipment purchased must originate in the EU or in an eligible country as defined above in the nationality rule

Exceptions to the rules

- Decided on a case by case basis by the EC
- Experts: with regard to nationals of other countries the EC may approve if (a) the input is relatively small and/or (b) unique expertise is being required
- Supplies: justification required before EC approval given (justification on the basis of price will not be accepted)
