ministry in new locations without fear of leaving established churches leaderless Yet one should not suppose that through such diffusion ecclesiastical authority became diluted The leaders in Acts shared their authority without thereby losing it They were able to do this because their authority was based on deference and mutual honor not only on legal rights Thus the diffusion of ecclesiastical authority resulted in a net increase of authority which in turn propelled the growth of the church from the Conclusion
