Socially Responsible Investment Law Benjamin J Richardson, 2008-06-30 Environmental harm is commonly associated with companies that extract, consume and pollute our shared natural resources. Rarely are the unseen polluters, the financiers that sponsor and profit from eco-damaging corporations, placed at the forefront of the environmental debate. By doing so, Richardson posits that corporate financiers, including banks, hedge funds, and pension plans, will become more accountable to the goals of ensuring sustainable development.
