women should be seen as agents rather than victims This view is especially interesting in the context of domestic violence where hundreds of wives and servants prosecuted patriarchs for assault and in the Mohock Scare of 1712 where London's populace rose up in opposition to aristocratic violence The discussion is informed by a detailed knowledge of assault laws and the rules governing justices of the peace
