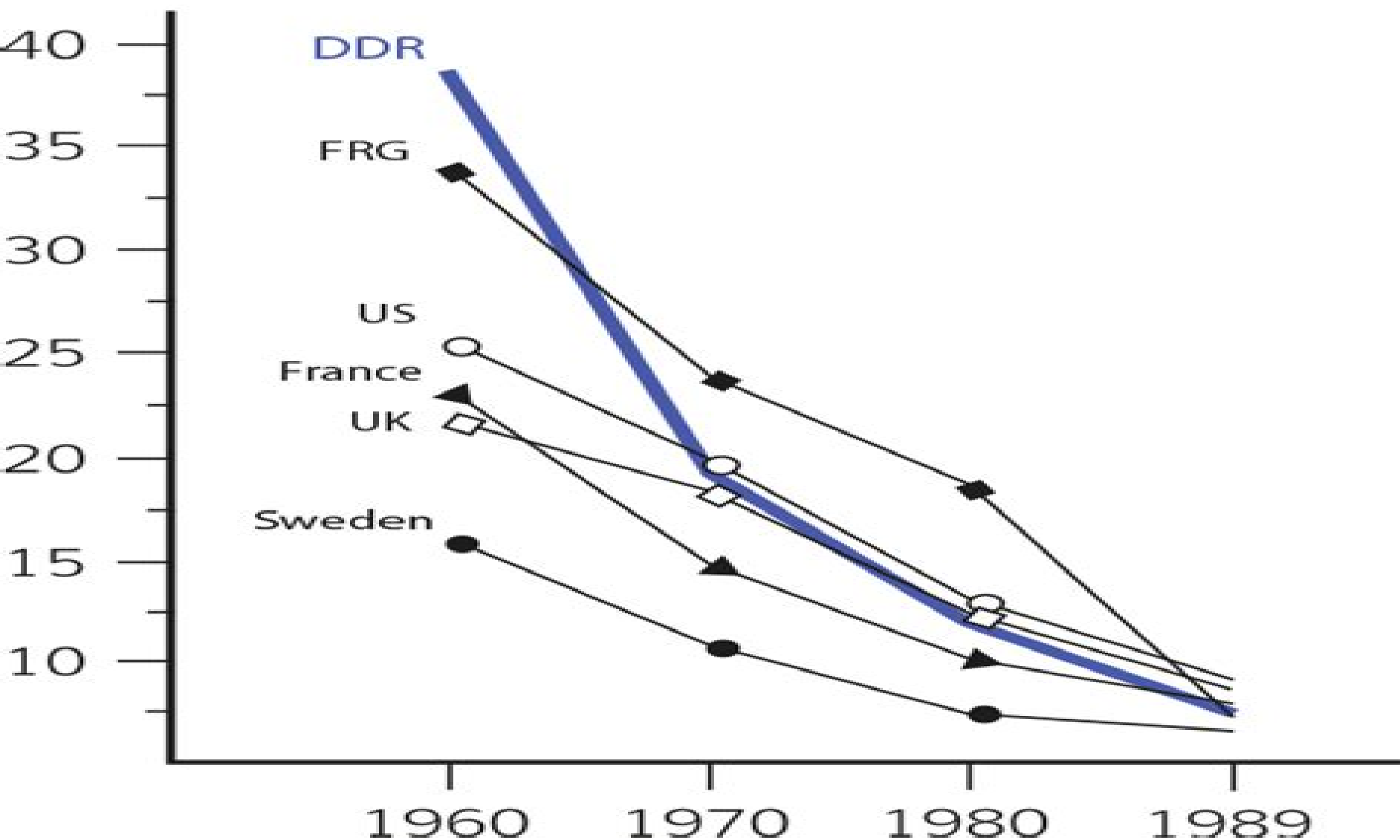


## Infant mortality rate:
