The Patient Griselda Myth Madeline Rüegg, 2019-06-04 From the 14th until the 19th century the last novella of Boccaccio's Decameron also known as the Griselda story has been translated and adapted countless times in many European languages. This story's success can be explained by considering it a myth and analysing how this myth engages with contemporary discourses such as the definition of the ideal wife, the querelle des femmes, the socio-political consequences of social exogamy and tyranny.

**The Evolution of the Patient Woman** Grace Annelyse McCarthy, 2015 English literary tradition contains a progression of the character Patient Griselda through narratives by Geoffrey Chaucer, John Phillips and Thomas Dekker. Little critical attention has been paid to Patient Griselda stories and much of the criticism contextualizes or dismisses Patient Griselda rather than engaging in close reading of the character. Each successive storyteller produced and reproduced a slightly different Patient Griselda for their generation, however, and examining the evolution of Patient Griselda allows specific differences in the narratives to come to light. These key narrative differences suggest a strong argument for Thomas Dekker's *The Pleasant Comedy of Patient Grissil* as the most immediate Griselda source for Shakespeare's *The Winter's Tale*. Scholars have largely ignored the Patient Griselda influences in *The Winter's Tale*. What little scholarship has been done on this topic attempts to connect Shakespeare's Griselda story elements to Chaucer. The similarities between Dekker's Griselda and Shakespeare's play, however, are too significant to ignore. Within *The Winter's Tale* are elements from Dekker's Griselda story which exist nowhere else in the English literary tradition of Patient Griselda. Through close readings of the works of Shakespeare, Middleton, Dekker, Heywood and others across the genres of domestic comedy, city comedy and revenge tragedy, Sarah Lewis shows how temporal tropes are used to delineate masculinity and femininity on the early modern stage and vice versa. She sets out the ways in which the temporal constructs of patience, prodigality and revenge, as well as the dramatic identities that are built from those constructs and the experience of playgoing itself, negotiate a fraught opposition between action in the moment and delay in the duration. This book argues that looking at time through the lens of gender and gender through the lens of time is crucial if we are to develop our understanding of the early modern cultural construction of both.

**Jane Eyre's Fairytale Legacy at Home and Abroad** Abigail Heiniger, 2016-03-02 Exploring the literary microcosm inspired by Brontë's debut novel, Jane Eyre's Fairytale Legacy at Home and Abroad focuses on the nationalistic stakes of the mythic and fairytale paradigms that were incorporated into the heroic female bildungsroman tradition. Jane Eyre, Abigail Heiniger argues, is a heroic changeling indebted to the regional pre-

Victorian fairy lore Charlotte Bront heard and read in Hawthorne an influence that Bront repudiates in her last novel *Villette*. While this heroic figure inspired a range of female writers on both sides of the Atlantic Heiniger suggests that the regional aspects of the changeling were especially attractive to North American writers such as Susan Warner and L M Montgomery who responded to *Jane Eyre* as part of the Cinderella tradition. Heiniger contrasts the reactions of these white women writers with that of Hannah Crafts whose *Jane Eyre* influenced *The Bondswoman's Narrative* rejects the Cinderella model. Instead Heiniger shows Crafts creates a heroic female bildungsroman that critiques fairytale narratives from the viewpoint of the obscure oppressed workers who remain forever outside the tales of wonder produced for middle class consumption. Heiniger concludes by demonstrating how Bront's middle class American readers projected the self rise ethic onto *Jane Eyre* mirroring the novel in nineteenth century narratives of American identity formation.

Trollope's mother wife and a friend he loved platonically most of his life provided him three very different views of the Victorian woman. And according to Jane Nardin they were responsible for the dramatic shift in his treatment of women in his novels. This is the first book in Sandra Gilbert's *Ad Feminam* series to examine a male author. Nardin initially analyzes the novels Trollope wrote from 1855 to 1861 in which male concerns are central to the plot and women are angelic heroines submissive and self sacrificing. Even the titles of his novels written during this period are totally male oriented. *The Three Clerks*, *Doctor Thorne* and *The Bertrams* all refer to men. Shortly after meeting Kate Field Trollope wrote *Orley Farm* which refers to the estate an angry woman steals from her husband and which marks a change in the attitudes toward women evident in his novels. His next four books *The Small House at Allington*, *Rachel Ray*, *Can You Forgive Her?* and *Miss Mackenzie* prove that women's concerns had become central in his writing. Nardin examines specific novels written from 1861 to 1865 in which Trollope with increasing vigor subverts the conventional notions of gender that his earlier novels had endorsed. Nardin argues that his novels written after 1865 and often recognized as feminist are not really departures but merely refinements of attitudes Trollope exhibited in earlier works.
