#### Intervention in Summary Proceedings

The word "and," whether it is used to connect words, phrases or full sentences, must be accepted as binding together and as relating to one another. [Commissioner of Internal Revenue vs Ariete, G.R. No. 164152, January 21, 2010]

Under the rules on syntax, the conjunctive word "and" denotes a "joinder or union" of words, phrases, or clause, it is different from the disjunctive word "or" that signals disassociation or independence. However, a more important rule of statutory construction dictates that laws should be construed in a manner that avoids absurdity or unreasonableness.
