Frames are mental and social constructs that influence perception, interpretation, and response to societal issues. They are not fixed; rather, they are constructed, contested, and strategically employed to shape outcomes. In law, framing determines whether a particular issue is recognized as a legal problem, how it is understood, and what solutions are considered appropriate. For example, framing a dispute as a matter of individual rights versus social justice can lead to different legal strategies and policy responses. Legal framing can be used strategically by actors to influence political debates, policy decisions, and judicial outcomes, often aligning with broader societal goals or power interests. Recognizing the fluidity and contestability of frames is essential for understanding how law interacts with society and how legal issues are constructed and contested in public discourse and legal processes.

Lawfulness vs Justice

Lawfulness means compliance with legal rules, which is a low standard; actions can be lawful yet produce unjust or harmful outcomes, highlighting the gap between legality and morality or justice.

Lawfulness refers to actions, policies, or decisions that meet the minimum legal requirements—adherence to statutes, regulations, and judicial precedents. However, legality does not inherently equate to justice or morality. For instance, a government policy might be lawful under current
