Decision Process Institute of Medicine, Board on Military and Veterans Health, Committee on Improving the Disability Decision Process: SSA's Listing of Impairments and Agency Access to Medical Expertise, 2007-05-14 The Social Security Administration SSA provides Social Security Disability Insurance SSDI benefits to disabled persons of less than full retirement age and to their dependents SSA also provides Supplemental Security Income SSI payments to disabled persons who are under age 65 For both programs disability is defined as a medically determinable physical or mental impairment that prevents an individual from engaging in any substantial gainful activity and is expected to last at least 12 months or result in death Assuming that an applicant meets the nonmedical requirements for eligibility e g quarters of covered employment for SSDI income and asset limits for SSI the file is sent to the Disability Determination Services DDS agency operated by the state in which he or she lives for a determination of medical eligibility SSA reimburses the states for the full costs of the
