# Television Network News Coverage of the Eagleton Affair: a Case Study

Two networks were positive, one slightly negative in both news stories and commentaries. Results dispute notion that networks are uniform.

➤ On Aug. 1, 1972, Sen. Thomas Eagleton signed his resignation letter as vice presidential candidate for the Democratic Party, becoming the first man in American history to do so. This climaxed a week-long battle to retain his place on the Democratic ticket and signaled the end of what came to be known as the Eagleton Affair.

After the dust had settled on the Eagleton Affair, it was clear that evaluations of media performance during this period were far from flattering. "In the Eagleton Affair," one columnist wrote, "the nation had a taste, more of a taste than it liked, of the media's capacity for inhumanity to man." Another writer called media performance "a mob scene out of Shakespeare... (displaying) all the tyrannous powers that our country has traditionally feared to be vested in the hands of government."

The Eagleton episode provides a good case study of media performance during the 1972 elections because of its specific and limited scope. The performance of television news will be analyzed according to the following research questions:

 Was network evening news coverage disproportionately negative to Thomas Eagleton?

■ The author is a member of the journalism faculty at Kent State University. 2) How much attention—in terms of length and number of stories—was given by the network newscasts to the Eagleton story, relative to other political campaign stories?

3) Was there a difference between networks in the degree of favorability or unfavorability of coverage of the Eagleton story?

4) Was there a difference in the degree of favorability or unfavorability towards Eagleton between a network's news coverage and its commentary?

# Method

Materials and Sample. A videotape compilation of all network evening news stories on Thomas Eagleton between July 25, 1972, and August 1, 1972, was obtained from the Vanderbilt University Television News Archive. The sample included 20 news stories and 5 commentaries from ABC; 17 news stories and 2 commentaries for CBS; and 16 news stories and 3 commentaries for NBC.3

The Coefficient of Imbalance. The coefficient of imbalance presents "an overall estimate of the degree of imbalance, i.e., the extent to which favorable, neutral, or unfavorable treatment is accorded to the topic or symbol under analy-

"NBC actually had one commentary ("David Brinkley's Journal") on Fagleton. However, anchorman John Chancellon presented what amounted to a panel discussion with two reporters who had been covering the McGovern and Fagleton campaigns. The discourses of each of these reporters were counted as commentaries rather than news stories.
