Remembering Defeat Andrew Wolpert,2003-05-22 In 404 b c the Peloponnesian War finally came to an end when the Athenians starved into submission were forced to accept Sparta s terms of surrender Shortly afterwards a group of thirty conspirators with Spartan backing the Thirty overthrew the democracy and established a narrow oligarchy Although the oligarchs were in power for only thirteen months they killed more than 5 percent of the citizenry and terrorized the rest by
