Other events presented opportunities for bold, forthright public service by the Judge Advocates General of the time: the Army's growth from 200,000 to eight million men in World War II; implementation of a revolutionary Uniform Code of Military Justice during combat in Korea; and the most recent problems of a new kind of war and new forms of public reaction. Judge Advocates General George Davis, Myron Cramer, Ernest Brannon, and Charles Decker, among others, were the architects of adjustment to the demands of modern war and politics as the world's largest law firm finished the last decades of its second century.
