Common wisdom sees North-South conflict as a product of poverty, slow growth, and ignorance. Intense debates among adherents of conventional liberal, basic human needs, and interdependence viewpoints have emphasized economics at the expense of politics in their analyses of relations between developed and developing states. In *Structural Conflict*, Stephen D. Krasner challenges this economic perspective, arguing instead that many North-South conflicts are rooted in profound asymmetries of power, and that political weakness and vulnerability are fundamental sources of Third World behavior.

Krasner demonstrates that developing countries have consistently endorsed principles and norms that legitimate authoritative allocation based on the decisions of states rather than market allocation based on the endowments and preferences of private actors. His meticulously researched study begins by describing the international and domestic weakness of Third World states and by tracing the evolution over time and across issue areas of Third World ideological coherence, the declining power of the North, and the nature of existing international organizations. Part II of the book offers detailed case studies of the international regimes affecting international financial institutions and multinational corporations. The study concludes with prescriptions for Northern policy, and the prediction that North-South conflict will persist regardless of the pattern of economic development. A provocative and lucidly argued work, *Structural Conflict* offers a probing analysis of the dynamics of North-South relations for the 1980s and beyond.
