

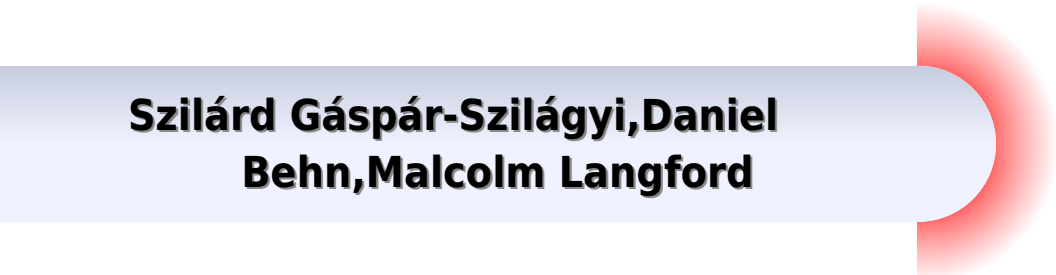
Challenges of Professional Service Firms with Internationalization

1. Professional qualifications that allow firms to practice law, dentistry, medicine, or accounting in the home country are rarely recognized by other countries. E.g., if you are certified a CPA in the U.S. and would like to practice accounting in Argentina, you must earn local certification in that country.
2. Professionals who work abroad for long periods generally must obtain work visas in the countries where they are employed.
