

SPELLING RULES



I before E, except after C:

One of the most well-known spelling rules, this guideline helps with words like "believe" and "receive." Remember, exceptions exist, but this rule covers a wide range of words.

Examples: Believe, receive, relieve, conceive Exceptions: Weird, science, efficient, sufficient

Silent E at the End:

When a word ends in an "e," it usually makes the preceding vowel long. For instance, "cute" vs. "cut." This rule is especially handy when dealing with words like "hope" and "hop."

Examples: Hope, Fine, Theme, Code, Dune

Exceptions: Have, Live, Love, Give, The

Double the Final Consonant:

When adding a suffix to a word, if the last three letters are a consonant followed by a vowel and another consonant, double the final consonant.

Examples: Run-Running, stop- stopped,

forget- forgetting, Hop- Hopping, Big - Bigger

Exceptions: Ran- Raining, hope- hoping, drop- dropped, swim- swimmer

Magic "E" Exceptions:

Sometimes, the magic "e" at the end of a word doesn't follow the typical rule. Being aware of these exceptions will strengthen your grasp on this spelling concept.

Examples: Hop -Hope, Tap- Tape, Bit- Bite, Rat-

Rate, Can- Cane

Exceptions: Give, love, have, one, love, like

C or K?

Determining when to use "c" or "k" can be tricky. Generally, if the sound is hard, use "k," and if it's soft, use "c."

Examples: Cat, circle, city, back, pick, seck

Exceptions: Car, coat, cut, chocolate, keyboard

Y as a Vowel:

When "y" serves as a vowel and there is a consonant before it, the preceding vowel usually has a long sound. Think of words like "cry" and "fly." Applying this spelling rule helps with words such as "try" and "myth."

Examples: Sky, Cry, Gym, fly, cry, try, myth Exceptions: Bevond, Baby becomes Babies

Adding S and ES:

Understanding when to add "s" or "es" to pluralize a word is crucial. Generally, add "s" to words ending in a vowel, and "es" to those ending in a consonant. This rule is applicable to words.

Examples: Bus-buses, box- boxes, quiz- quizzes,

cat- cats, dog -dogs

Exceptions: Toy- toys, boy- boys, man- men,

woman- women

Common Prefixes and Suffixes:

Understanding common prefixes and suffixes can significantly aid your spelling skills. Prefixes are added to the beginning of a word, and suffixes are added to the end. Recognizing these patterns can help you spell words correctly without memorizing each one individually.

Examples: unhappy or undo, quick to quickly, Rewrite,
Revisit.

Exceptions: Hope- Hoping, Drive- Driving, Happy-Happier, Carry-Carried.
