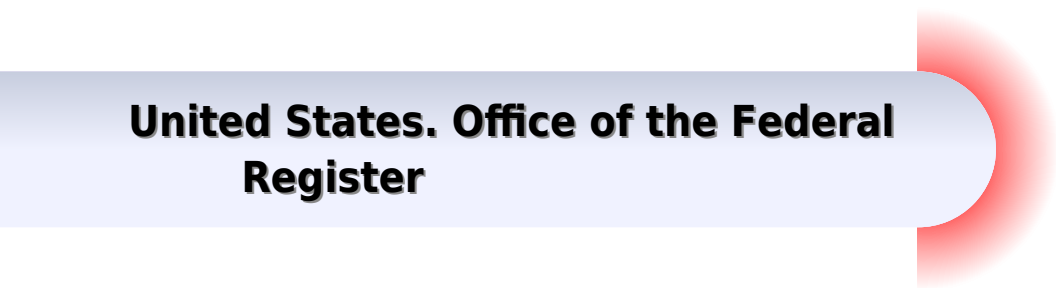

as a means to stimulate economic activity create jobs and assist in the national economic recovery Others worry that an expanded SBIC program could result in losses and increase the federal deficit In their view the best means to assist small business promote economic growth and create jobs is to reduce business taxes and exercise federal fiscal restraint Some Members have also proposed that the program target additional assistance to startup and early stage small businesses which are generally viewed as relatively risky investments but also as having a relatively high potential for job creation In an effort to target additional assistance to newer businesses the SBA has established as part of the Obama Administration's Startup America Initiative a 1 billion early stage debenture SBIC initiative up to 150 million in leverage in FY2012 and up to 200 million in leverage per fiscal year thereafter until the limit is reached Early stage debenture SBICs are required to invest at least 50% of their investments in early stage small businesses defined as small businesses that have never achieved positive cash flow from operations in any fiscal year This publication describes the SBIC program's structure and operations including two recent SBA initiatives one targeting early stage small businesses and one targeting underserved markets It also examines several legislative proposals to increase the leverage available to SBICs and to increase the SBIC program's authorization amount to 4 billion
