The most replicated early model of Restorative Justice based on the well-known Elmira Case was a Canadian first, initially dubbed Victim Offender Reconciliation Project (VORP). The author became its second director in 1977. The term mediation later displaced the more religious word reconciliation as the model spread outside Christian moorings, and the program displaced the initially more tentative project.
