- Taking account of tax effects and private provision drastically changes the conventional picture about the size of the welfare state.
- Scandinavian countries are no longer so large welfare states as they are traditionally perceived, owing to the crawling-back effect of tax system.
- Rather surprisingly, the U.S. is the second largest welfare state in Net Total, owing to private provision of social support.
- Australia's position does not change in both gross and net social expenditure at this time.
- Australia will be considered as the large hidden welfare state if the size of superannuation increase.
- Countries with Gross Pub less than average are likely to have higher PrivPubRatio.
- Consequently, the variation in Net Total across nations is smaller than in Gross Pub.
