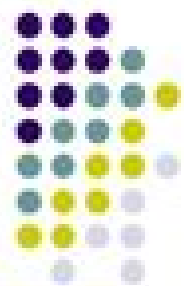


Control of taxation 1: Medieval England's Parliament



- Guards against despotic royal rule.
- Limit kings' powers to impose taxes
- Limit standing army beyond times of war.
- 1689 Bill of Rights established principle that only Parliament could authorize taxation:
'... levying money for or to the use of the Crown by pretence of prerogative, without grant of Parliament ... is illegal.'
- No annual budget, no control of expenditures.
