By employing a unique cross-regional comparative framework, *The Left Transformed* explores the divergent trajectories of ex-ruling communist parties in key countries of the former Soviet Empire. In-depth interviews, party presses, and primary documents and national election data provide a foundation for the most up-to-date examination of party transition, organization, ideology, and electoral fortunes through late 2002. Last, some defects are reflected upon as well as unfinished processes related to the fast establishment of political parties in the region, e.g., absence of firm links with social groups, high volatility, instability of parties, etc.
