The Hellenistic Aesthetic Barbara Hughes Fowler, 1989 Fowler's own insights are apparent throughout and they seem to distill the personal appreciation and understanding of a scholar who has devoted much of her career to both contemplating and enjoying Hellenistic poetry. Passages are quoted in the original Greek translated and analyzed. Fowler's sensitivity to poetic forms evident in her other published writings is again evident here. In addition, however, the philosophical context is not overlooked. Also highly commendable are the liberal references to works of art. Sculpture in the round and in relief, portraits, terracotta figurines, original paintings, grave stelai and Campanian murals, mosaics, gold and silver vessels and jewelry are introduced at various points. Every work of art discussed is illustrated in astonishingly clear photographs which are interspersed in the body of the text. Fowler examines parallels both in subject matter and in artistic approach among a diverse group of literary genres and artistic forms. Kallimachos Rudolf Blum,2011-06-01 The famous library of Alexandria founded around 295 BCE by Ptolemaios I housed the greatest collection of texts in the ancient world and was a fertile site of Hellenistic scholarship Rudolf Blum s landmark study originally published in German in 1977 argues that Kallimachos of Kyrene was not only the second director of the Alexandrian library but also the inventor of two essential scholarly tools still in use to this day the library catalog and the biobibliographical reference work Kallimachos expanded the library s inventory lists into volumes called the Pinakes which extensively described and categorized each work and became in effect a Greek national bibliography and the source and paradigm for most later bibliographic lists of Greek literature Though the Pinakes have not survived Blum attempts a detailed reconstruction of Kallimachos s inventories and catalogs based on a careful analysis of surviving sources which are presented here in full translation

The Codrus Painter Amalia Avramidou,2011-01-06 The Codrus Painter was a painter of cups and vases in fifth century B C E Athens with a distinctive style he is named after Codrus a legendary Athenian king depicted on one of his most characteristic vases He was active as an artist during the rule of Pericles as the Parthenon was built and then as the troubled times of the Peloponnesian War began In contrast to the work of fellow artists of his day the vases of the Codrus Painter appear to have been created almost exclusively for export to markets outside Athens and Greece especially to the Etruscans in central Italy and to points further west Amalia Avramidou offers a thoroughly researched amply illustrated study of the Codrus Painter that also comments on the mythology religion arts athletics and daily life of Greece depicted on his vases She evaluates his style and the defining characteristics of his own hand and of the minor painters associated with him Examining the subject matter figure types and motifs on the vases she compares them with sculptural works produced during the same period Avramidou s iconographic analysis not only encompasses the cultural milieu of the Athenian metropolis but also offers an original and intriguing perspective on the adoption meaning and use of imported Attic vases among the Etruscans
