This state of affairs has significant real world ramifications as international legal rights and obligations of individuals and other non state entities are frequently applied more restrictively than interpretation without presumptions regarding personality would merit.

After World War II Austria was occupied by Soviet American British and French forces. This study provides the history of the treaty that was negotiated in order to end this occupation. In the Moscow Declaration of 1943 the United States Great Britain and the Soviet Union had declared that Austria should be liberated from Nazi rule and reconstructed as an independent state. After the war however this goal was soon overshadowed by security and power considerations and then by the Cold War. While the West strove to safeguard Austria's independence from communist expansion the USSR refused to finalize a treaty and to withdraw from its zone in the eastern part of the country. In the end it took until 1955 to come to an agreement and receive Soviet consent for a treaty. An important Soviet precondition for agreeing to withdraw was Austria becoming a permanently neutral country. The roots of Austria's neutrality as traced in this volume were not only linked to Soviet but also to Austrian considerations.
