and those of the government s best ballistic experts were kept out of the official report The Commission s tortuous Single Bullet or Magic Bullet theory is finally and convincingly dismantled Oswald was probably a low level asset of the FBI or CIA or both Commission members Gerald Ford for the FBI and Allen Dulles for the CIA acted as informers regarding the Commission s proceedings The strong dissenting views of Commission member Senator Richard Russell D Georgia were suppressed for years
