The contributors to this volume share the belief that social science can and should influence legal policymaking Empirical research is necessary to offset anecdotal evidence and untested assertions But research that is acceptable to the academy may not stand up in court and as a result social science does not always get a sympathetic hearing from legal decision makers. The relationship between social science and the law will always be complex this volume takes a lead in showing how it can nonetheless be productive **Justice** Corey S.
