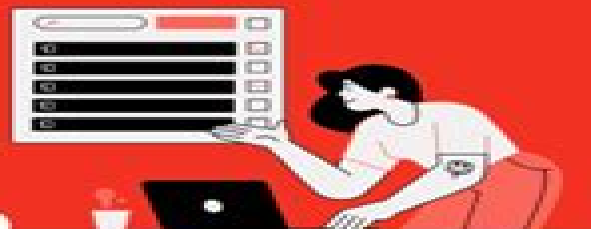

Filing for bankruptcy imposes an automatic stay on debt collection activities.



## ATTEND THE MEETING OF CREDITORS

Filing bankruptcy requires attending a meeting with creditors and trustee to discuss your finances.



## COMPLETE FINANCIAL MANAGEMENT COURSE

After the meeting of creditors, you must complete a financial management course to receive a bankruptcy discharge.



## RECEIVE DISCHARGE

In Ch. 7 bankruptcy, eligible debts are discharged after assets are liquidated to pay creditors. In Ch. 13, debts are discharged after completing the repayment plan.



## REBUILD YOUR CREDIT

Bankruptcy will affect your credit score, but over time, you can rebuild it by responsibly managing your finances, paying bills on time, and using credit wisely.
