WHEREAS the importation of negroes from the *West-India* islands, and colonies upon the continent, who have been any time in such islands or colonies, is greatly detrimental to the inhabitants of this province, as in general such negroes are either sent from thence by private persons for their ill behaviour, or transported by the courts of justice: And whereas the act authorizing commissioners to repair the light-house on *Tybee* island is near expiring.
