Faith-Based Initiatives and Aging Services addresses the issues of the separation of church and state, the concerns involved in developing social services in religious congregations, and the larger public policy implications of this office. This unique book offers perspectives from traditional and nontraditional faith-based groups as well as experts in volunteerism. The enactment by Congress of the Charitable Choice section of the federal welfare reform law combined with the creation of the Center for Faith-Based and Community Initiatives in the United States Department of Health and Human Services to signal a high level of interest in supporting faith-based organizations. Ellor conducted an in-depth interview with Elizabeth Seal Scott, then Director of the Center for Faith-Based and Community Initiatives; an edited transcript of the interview is included in the book to help promote understanding of the development and implementation of faith-based grass roots programs.
