and statute/rule.

At the trial, the client's defense attorney will tell the client's side
of the story, the prosecutor will tell their side of the story, and
the judge will decide if the prosecution has proved the charges.
(their side of the story).

At the trial, the judge determines whether the charges filed
against the juvenile are proven, and if you are guilty or not
guilty.

Review with the client the roles of the defense attorney and
prosecutor, and introduce additional courtroom personnel and
their roles in the courtroom.

Provide a basic overview of the general juvenile court
process in order to help them become familiar with what to
expect and to reduce their anxiety about participating in
their own court proceedings.
