A transaction where a company's management team purchases the assets & operations of the business they manage.

02

A management buyout (MBO) is appealing to professional managers because of the greater potential rewards from being owners of the business rather than employees.

03

The financing required for an MBO is usually a combination of debt & equity that is derived from the buyers, financiers & sometimes the seller.

04

The advantages of MBO is that as the existing managers are acquiring the business, they have a much better understanding of it & there is no learning curve involved.

05

Another advantage is that the company's debt load may be lower, giving it more financial flexibility.
