EXEGESIS:

ROMANS 6: A REVIEW

In the first half of this chapter (vv. 1-11) Paul established that with our baptism we became new creatures – we died with Christ and were resurrected to a new life with him. Therefore, we must consider ourselves "dead to sin, but alive to God in Christ Jesus our Lord" (v. 11).

In the rest of this chapter (vv. 12-23), Paul specifies the theological implications of our new birth. We must act according to this new nature. It is not appropriate for us to give dominion over our lives to sin – to become slaves to it – now that we have been resurrected with Christ. Instead, we need to give dominion to God – become slaves of God. Paul does not imply that we are free in the sense of having no master. We serve sin or God. No choice.

Paul often makes paired contrasts to demonstrate this point. "In this lectionary, there are three pairs that come into play: Sin versus justice (or sin versus God), freedom versus slavery, and wages versus gift" (Gaventa, 384).

ROMANS 6:12-14: THEREFORE, DO NOT SIN REIGN

12 Let not sin therefore reign in your mortal body, so that you obey it in its lusts (Greek: epithumiais – passions or lust); 13 Nor present your members to sin as an instrument (Greek: hopla – weapons, tools) of iniquity; but present yourselves to God as living from the dead, and your members to God as instruments (hopla) of righteousness. 14 For sin will not have dominion over you; for you are not under the law, but under grace.

"...well..." (v. 12) joins what follows with what Paul has previously said. He has established that we are new people in Christ (vv. 1-11). Now, state what this means regarding our conduct (vv. 12-23).

"Let no sin reign in your mortal body" (v. 12). "The pleasures of sin take place in a body that, even at its best, remains mortal and fleeting, but Paul is talking about a life in Christ that brings eternal joy. It is absurd to let what is going to die have supreme position" (Morris, 257). "The battle is spiritual and is fought, lost, or won with the believer's daily decisions regarding how to use his or her body" (Moo, 383).
