For laying a Duty upon Negroes and other Slaves that have been above six Months in any of the Islands or Colonies in America, and imported for Sale in this Province, and for appropriating the same towards the repairing or rebuilding the Light-house on Tybee Island; and to prevent Negroe Convicts being imported into and sold in this Province.

WHEREAS the importation of negroes from the *West-India* islands, and colonies upon the continent, who have been any time in such islands or colonies, is greatly detrimental to the inhabitants of this province, as in general such negroes are either sent from thence by private persons for their ill behaviour, or transported by the courts of justice: And whereas the act authorizing commissioners to repair the light-house on *Tybee* island is near expiring. We pray your most sacred Majesty that it may be enacted, And be it Enacted, by his Excellency JAMES WRIGHT, Esquire, Captain-General and Governor in chief of the province of

II. All slaves imported into this province, who shall be brought on shore in any ship, vessel, or other conveyance, and who shall be found on shore more than six months after the date of their importation, shall, if the master, merchant, or other person, by whom they were imported, shall be unable to produce a certificate, that the same have not been on shore on any of the islands or colonies of America, for more than six months, or that they were imported for the purpose of being sold in this province, it shall and may be lawful for the treasurer or comptroller aforesaid to take the oath of such master, merchant, or factor, or other person, that the same have not been on shore on any of the islands or colonies of America, for more than six months, or that they were imported for the purpose of being sold in this province, and if he shall be unable to do so, he shall be liable to pay a fine of five hundred pounds, to be levied at the discretion of the court of sessions, and the same shall be applied towards the repairing or rebuilding the light-house on *Tybee* island.

The American Law of Slavery, 1810-1860 Mark Tushnet, 2019-02-19 In an examination of Southern slave law between 1810 and 1860 Mark Tushnet reveals a structured dichotomy between slave labor systems and bourgeois systems of production Whereas the former rest on the total dominion of the master over the slave and necessitate a concern for the slave's humanity the latter rest of the purchase by the

capitalist of a worker's labor power only and are concerned primarily with economic interest. Focusing on a wide range of issues that include contract and accident law as well as criminal law and the law of manumission, he shows how Southern slave law had to respond to the competing pressures of humanity and interest. Beginning with a critical evaluation of slave law, the author develops the conceptual framework for his own perspective on the legal system, drawing on the works of Marx and Weber. He then examines four appellate court cases decided in three different states from civil law Louisiana to commonlaw North Carolina at widely separated times from 1818 to 1858. Professor Tushnet finds that the cases display a continuing but never wholly successful attempt at distinguishing between law and sentiment as modes of regulating social interactions involving slaves. Also, the cases show that the primary method of accommodating law and sentiment was an attempt to use rigid categories to confine the law of slavery to what was thought its proper sphere.
