The Transformation of Judaism Jacob Neusner, 2011-03-31 Jacob Neusner describes, analyzes and interprets the transformation of one system of the Israelite social order by a connected but autonomous successor system. He characterizes the successive systems classifying the one as philosophical and the other as religious.
