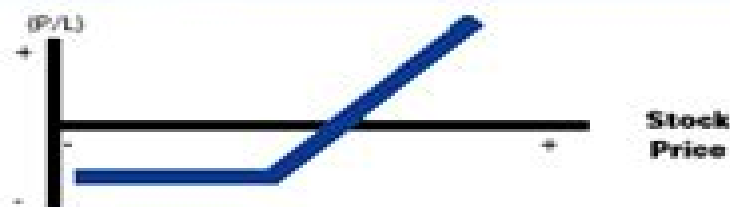


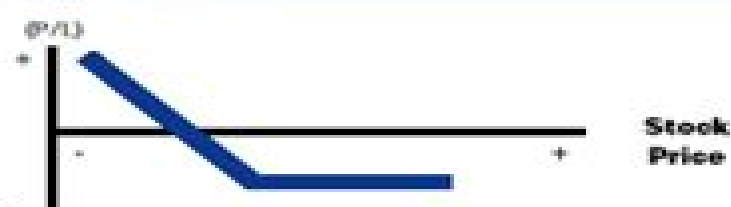

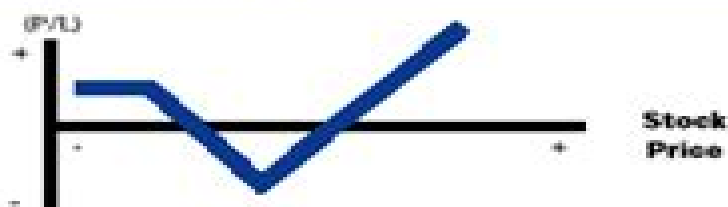
Long Put

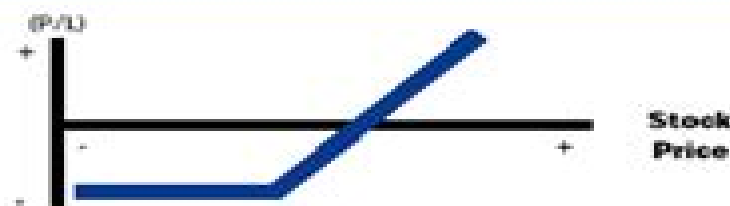
Put Backspread

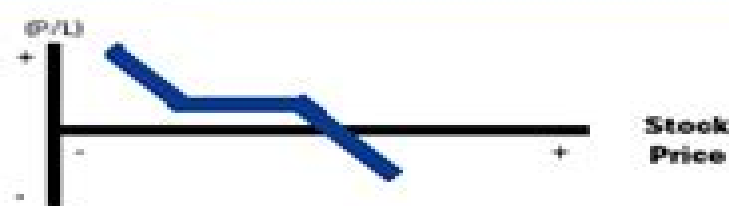
Protective Put *
