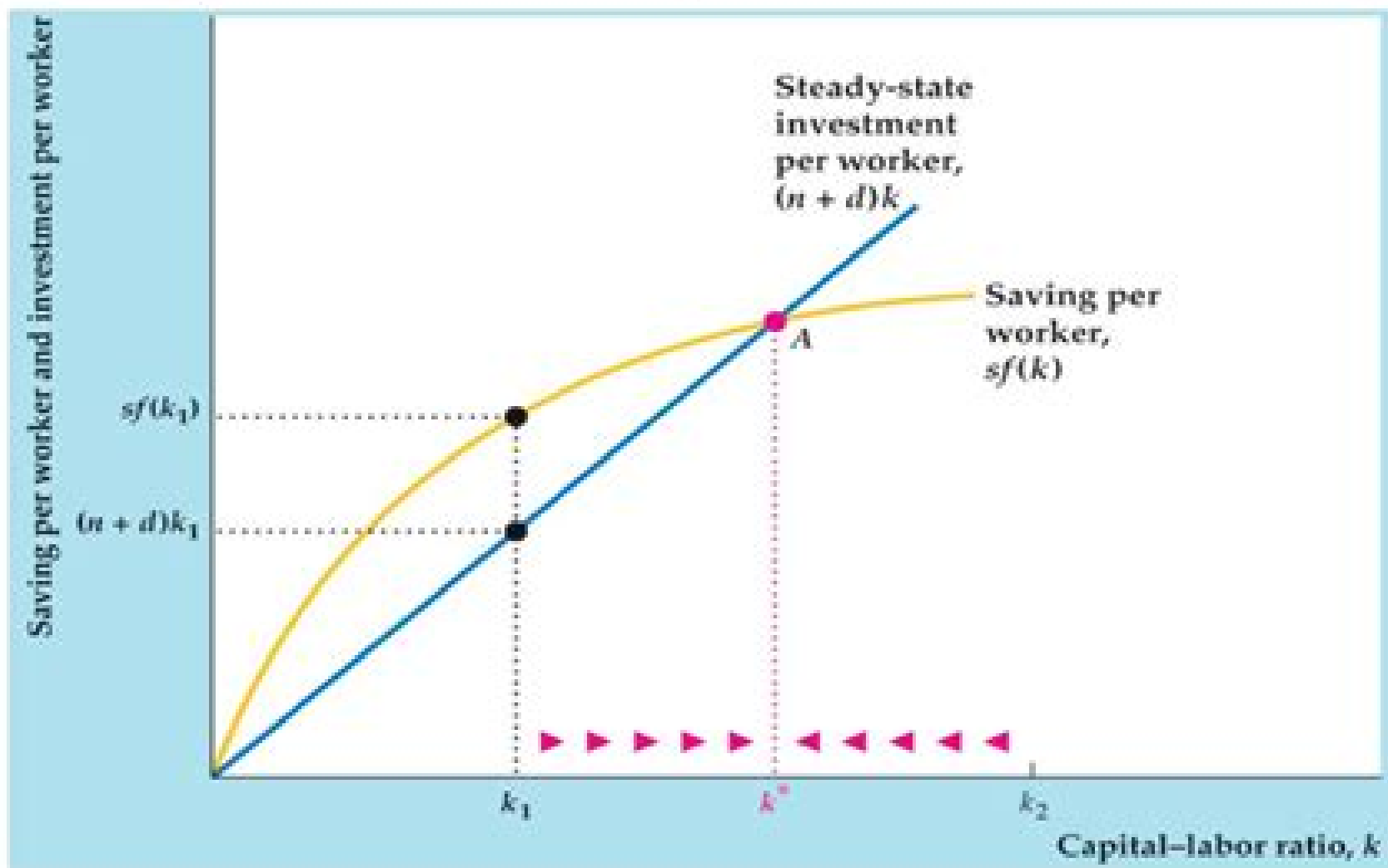


Figure 6.5 Determining the capital–labor ratio in the steady state
