sometimes frustrating hours conducting research in the National Archives Library of Congress and the library of the Daughters of the American Revolution By 1999 I had amassed a great deal of genealogical information most of which was stuffed in cardboard boxes I was encouraged to put what I had on paper by Faye M Brown Lightburn who had published her book *Revolutionary Soldier Samuel Brown and Some of his Family* in 1993 So after attending several related sessions at the National Genealogical Society Conference in the States which was held that year in Providence Rhode Island I finally screwed up my courage and plunged in I published the original book in 2003 This book is the second and probably last edition
