This is so because the term tax harmonization has been developed, in response to the practical need for a general and comprehensive term which can cover a wide range of tax adjustment programs that are as yet not being identified definitely, though likely to be necessary to help in achieving a number of broad, and often competing, political and economic objectives of an economic integration. It has come to be understood that the term is often used in a special sense, with relevance only for the EEC.
